General Manager Reports:

7. The FY 22-23 Audit has been completed and filed before the due date for the first time in over 10 years. The new roof is completed and being inspected before the end of the month. The roofing company did advise that the roof was rotted and dilapidated. The swamp coolers were falling in and causing a safety hazard. The donated fines have been being delivered by McKenzie Ruth weekly and we have received 3,000 of the expected 8,000 tons. For the month of December we had 8 interments, 4 of which were full and 4 cremains. I emailed the "Friends of Barstow Cemetery" to set up a meeting with them but they were unavailable for the month of January and have requested that we try for February. Cemsites has received the item list and prices from us and are in the final stages of getting the website ready. Emily and myself have continued to work with our Quickbook Pro on getting the previous months reconciled and entered in the correct accounts. I attended the LAFCO meeting in San

Bernadino on January 17, 2024 as well. Michael Tuerpe presented the same findings he had reported to us in Decembers meeting. He stated they are now seeing satisfactory results and is not recommending that the county step in but rather provide help in training. I will attend another meeting in May to present a progress report to the LAFCO board. Ethics training is due for the year so both the Board Members and staff will need to sign up for the CSDA offered training. CSDA as well offers free webinar trainings that we recommend everyone take to further our knowledge and to keep in compliance with the results LAFCO would like to see. As of now the gate is opened and closed by the staff on the weekends when the office is not open. This is resulting in unnecessary overtime costs. The gate also causing a liability issue and safety concern. My suggestion is to remove the opening and closing of the gate and rather get security cameras so we can leave the gates open. Barstow Cemetery District now has a public Facebook page that will be putting out information and open a forum for community questions and concerns.
